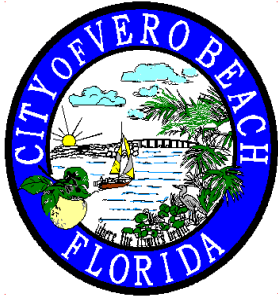

_____ **There will be a MANDATORY parade meeting held on October 25th from 5:30 p.m. to 7:00 p.m. at Riverhouse.**

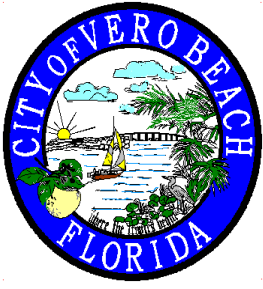
There will be two (2) other meetings held leading up to the parade.
